#### **DECLARATION AND PRIVACY CONSENT**

## Authority to disclose personal information

We need to collect personal information about you to provide you with our broking & related services. This privacy statement tells you how we collect your information, what we use the information for and who we share the information with. #### How information is collected from you
